

## VILLA TERESA SCHOOL FEES 2009-2010

Summer Registration is \$125.00 per child (this is a non-refundable fee).

Fall Registration is \$140.00 per child (this is a non-refundable fee).

Fall book fees are as follows: LC3 Activity Fee \$35.00, LC4 \$50.00, and K-4<sup>th</sup> \$115.00 to be paid with the registration.

Tuition is as follows: 1 child \$460.00, 2 children \$870.00, 3 children \$1,280.00.

You may pay in two installments, or by semester and receive a 5% discount. The fees are:

You may also pay in full for the school year and receive a 5% discount. The fees are:

St. Anthony's Employee Tuition Rates are as follows (both the Summer and the Fall):

Monthly Tuition: 1 Child \$390.00 2 Children \$730.00 3 Children \$1,070.00

If you pay by semester: 1 Child \$1,667.25 2 Children \$3,120.75 3 Children \$4,574.25 due on August 1 and December 1.

If you pay in full: 1 Child \$3,334.50 2 Children \$6,241.50 3 Children \$9,148.50

In Summer, if you are going to be gone on vacation or out for a week or more, please fill out the vacation time form at the office and turn it in prior to your being gone. This will then be sent to the Business Office so that you get credit for that time. You can take up to two weeks vacation during the summer.

Parents make their payments to the school office. The payments are due on the 1<sup>st</sup> and late by the 10<sup>th</sup>. In the event of failure to pay all tuition, fees and charges on or before specified due dates, the School reserves the right at anytime to suspend a student until all overdue payments have been made. The School shall in no way consider such suspension a breach of contract, nor shall it relieve the undersigned of the obligation to make such overdue payments and other agreed charges.

The monthly fees include \$35.00 for the school lunch program and \$230.00 that is applied to the before and after school program. There is NO REDUCTION for the students who do not eat a school lunch or use the before or after school care.
