



VILLA TERESA SCHOOL FEES 2012-2013

Summer Registration is **\$135.00** per child. Additionally, a Summer Activity Fee of **\$50.00** per child is required to offset the cost of the Summer program special activities. Both the Summer Registration and Activity Fees are non-refundable.

Fall Registration is **\$150.00** per child. Fall book fees per child are as follows: **LC3 - \$35.00, LC4 - \$50.00, K-4th - \$115.00.** Both the Fall Registration and Book Fees are non-refundable.

Tuition can be paid on a monthly, or school year basis and **must be paid by bank auto-draft.** Parents who choose to pay by a single payment for the entire school year will receive a **\$250.00 discount.** The school year runs from August 20, 2012 through May 18, 2013. The summer program runs from May 20, 2012 through August 10, 2012. Summer tuition can be paid at the regular monthly rate, or paid in full according to the schedule below. No discount is offered for full payment of summer tuition and **Summer Tuition will not be prorated.**

Payments made after the 10th will incur a **\$25.00 late fee.** In the event of failure to pay all tuition, fees, and charges on or before the specified due dates, the School reserves the right at anytime to suspend a student until all overdue payments have been made. The School shall in no way consider such suspension as a breach of contract, nor shall it relieve the undersigned of the obligation to make such overdue payments and other agreed charges.

**The monthly fees include \$35.00 for the school lunch program and ½ of the tuition is applied to the before and after school program. There is NO REDUCTION for the students who do not eat a school lunch or use the before or after school care.
